THE UNIVERSITY COLLEGE (AMENDMENT) BILL, 2011

MEMORANDUM OF OBJECTS AND REASONS

This Bill amends the University College Law (2010 Revision).

Clause 1 provides for the short title.

Clause 2 makes three changes to the principal Law.

First, section 3(3)(d) of the principal Law allowed for the appointment of two honorary members of the Board of Governors from outside the Islands, neither of whom had a vote. Clause 2(a)(i) repeals and substitutes paragraph (d) so as to allow the Governor in Cabinet to appoint one or both members as voting members.

Clause 2(a)(ii) amends section 3(3)(e) by removing the restriction that one of the two members appointed under that paragraph be from the College Faculty.

Third, clause 2(b) repeals and substitutes section 3(5) so as to clarify the range of options available to the Governor in Cabinet in designating a chairman and deputy chairman.

| (ii) by deleting from paragraph (e) the words “, one of whom shall be from the College Faculty”; and | |

- (b) by repealing subsection (5) and substituting the following subsection -

“(5) The Governor shall appoint -

- (a) two members appointed under subsection (3)(c) as chairman and deputy chairman, respectively; or
- (b) two members appointed under subsection (3)(e) as chairman and deputy chairman, respectively; or
- (c) one member appointed under subsection (3)(c) and one member appointed under subsection (3)(e), as chairman and deputy chairman, respectively, or vice versa.”.
