Under the Mutual Funds Law (2003 Revision)

1. The Cayman Islands Monetary Authority (the “Authority”), through this Industry Notice, hereby specifies or recognizes particular stock exchanges, overseas regulatory authorities, or approved countries for regulatory purposes, as required by the Mutual Funds Law (2003 Revision), as amended (the “MFL”).
2. Section 4(4) of the MFL provides (emphasis added to identify Authority’s specifications):
 - 4.(4) A mutual fund may carry on or attempt to carry on business in or from the Islands without complying with subsection (1) if: -

...

(b) it is a fund, not incorporated or established in the Islands, which makes an invitation to the public in the Islands to subscribe for its equity interests by or through a person who is the holder of a licence under the Securities Investment Business Law (2004 Revision), for a **regulated activity** specified by the Authority for the purposes of this subsection and –

(i) those interests are listed on a **stock exchange** (including an over-the-counter-market) specified by the Authority by notice in the Gazette; or

(ii) the fund is **regulated in a category**, and by an **overseas regulatory authority**, approved by the Authority for the purposes of this subsection.
3. The Authority specifies the **regulated activities** under the Securities Investment Business Law (2004 Revision) (“SIBL”) pursuant to s. 4(4)(b) of the MFL, as those licensees that hold a licence issued under SIBL as a broker dealers market maker, securities advisor, and securities arranger, but not a SIBL licensee that holds its license as a securities manager only.
4. For the purposes of specifying a **stock exchange** pursuant to s. 4(4)(b)(i) of the MFL, the Authority will apply the criteria described in its Regulatory Handbook at Appendix G12 for “Approved Stock Exchanges.” The Regulatory Handbook is available on the Authority’s website, at www.cimoney.com.ky, under Regulatory Framework / Regulatory Handbook.¹
5. For the purposes of approving an **overseas regulatory authority** (“ORA”) pursuant to s. 4(4)(b)(ii) of the MFL, the Authority will adopt the list of Overseas Regulatory Authorities that was published in the Cayman Islands Gazette (16/2003) (originally with respect to s.2 of the Securities and Investment Business Law (2004 Revision), and reproduced as the attached Appendix 1.

¹ The list of Approved Stock Exchanges is under review, but the following criteria will apply for an exchange to be so designated: (a) a US licensed exchange; or (b) an EU licensed exchange; or (c) a Canadian licensed exchange; or (d) a full member of the WFE1 that is located in a Schedule 3 country; or (e) the Cayman Islands Stock Exchange.

6. The Authority determines that appropriate funds that are **regulated in a category** for the purposes of s. 4(4)(b)(ii) of the MFL, are those that are regulated (in their domicile) as funds intended for other than “professional,” “qualified,” or “sophisticated” investors, or their equivalent (ie: those that are often referred to as “retail” funds).

7. Section 16(1)(d) of the MFL provides (emphasis added for clarity):

16.(1) A licensed mutual fund administrator shall not provide mutual fund administration to a mutual fund unless it has satisfied itself that –

(d) the mutual fund, if it is not incorporated or established in the islands, is incorporated or established **in a country or territory** approved by the Authority for the purposes of this subsection.

8. The **countries or territories** approved by the Authority for the purposes of s. 16(1)(d) of the MFL are those countries and territories specified in Schedule III of the Money Laundering Regulations (2006 Revision), and reproduced as the attached Appendix 2.
