THE ROADS LAW (2005 REVISION) Section 6, Authorisation to Enter Lands

In exercise of the powers conferred on the Governor in Cabinet by Section 6, The Roads Law (2005 Revision), and acting upon the recommendation of the National Roads Authority, it is hereby declared that:

1. It is in the public interest to widen a section of public road described hereunder;

REGISTRATION SECTIONS:	George Town Central, George Town South
REGISTRATION BLOCKS:	14BH, 14CJ, 14D
BOUNDARY PLAN:	BP 524
NATURE OF ROAD WORKS:	Widening of part of Elgin Avenue, George Town, as depicted in green

- 2. The National Roads Authority is authorised to enter upon lands listed in the Schedule below for the purposes of road works as publicly declared as intended under Section 3, The Roads Law (2005 Revision);
- 3. Such authority will take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette;
- 4. The line and anticipated boundaries of the road works are shown edged green on Boundary Plan 524 which may be inspected at the offices of the National Roads Authority or the Lands & Survey Department, both located in George Town, Grand Cayman, Cayman Islands.

1. It is the intention of the National Roads Authority to undertake road widening works to the road described hereunder:
