THE CRIMINAL PROCEDURE CODE (AMENDMENT) BILL, 2012

MEMORANDUM OF OBJECTS AND REASONS

This Bill amends the Criminal Procedure Code (2011 Revision) for the purpose of prescribing the mode of trial for various offences relating to child pornography, including -

- (a) taking or possessing an indecent photograph or pseudophotograph of a child;
- (b) publishing, possessing or accessing child pornography;
- (c) publishing child pornography through a computer system;
- (d) producing child pornography for the purpose of its publication through a computer system;
- (e) possessing child pornography in a computer system; and
- (f) accessing child pornography through a computer system.

ENACTED by the Legislature of the Cayman Islands.

1. (1) This Law may be cited as the Criminal Procedure Code (Amendment) Short title and commencement Law, 2012.

(2) This Law comes into force immediately after the Penal Code (Amendment) Law, 2012 comes into force.

2. Schedule 1 to the Criminal Procedure Code (2011 Revision) is amended by inserting in the respective columns, after section 223, the following items relating to sections 228A, 228B and 228C -
