THE CINEMATOGRAPH (AMENDMENT) RULES, 2013

In exercise of the powers conferred by section 9 of the Cinematograph Law (2009 Revision), the Cinematograph Board with the advice and consent of the Legislative Assembly makes the following Rules -

- 1. These Rules may be cited as the Cinematograph (Amendment) Rules, 2013. Citation

- 2. The Cinematograph Rules (2013 Revision), in these Rules referred to as the “principal Rules”, are amended in rule 4(1) by repealing subparagraph (b) and substituting the following subparagraph - Amendment of rule 4 of the Cinematograph Rules (2013 Revision) - licences
 - “(b) cinematographic exhibitions on Sundays, between the hours of 2:00 p.m. and midnight, in relation to films which have been designated by the British or American Film Censorship Authorities as suitable for viewing by children aged seventeen years and under.”.

- 3. The principal Rules are amended by repealing rule 6 and substituting the following rule - Repeal and substitution of rule 6 - annual licence fees
 - “Annual licence fees 6. The fees for annual licences are, for each screen in a building used for cinematographic exhibitions -
 - (a) \$100, if the charge for admission of a person does not exceed \$1.50;
 - (b) \$250, if the charge for admission of a person does not exceed \$2.00;
 - (c) \$750, if the charge for admission of a person does not exceed \$2.50; and
 - (d) \$1,500, if the charge for admission of a person exceeds \$2.50.”.

- 4. The principal Rules are amended in the proviso to rule 8 by deleting the words “sixteen years” and substituting the words “seventeen years”. Amendment of rule 8 - admission of children

5. The principal Rules are amended in rule 9 by deleting the words “sixteen years” wherever they appear and substituting the words “seventeen years”.

Amendment of rule 17 -
existing licences

6. The principal Rules are amended in rule 17 by repealing paragraph (b) and substituting the following paragraph -

“(b) be deemed to be subject to an additional condition that cinematographic exhibitions may be conducted on Sundays between the hours of 2:00 p.m. and midnight if the film to be exhibited has been designated by the British or American Film Censorship Authorities as suitable for viewing by children aged seventeen years and under.”.
