ROADS LAW (2000 REVISION) Section 25 (4) (a)

ROADS LAW (2000 REVISION) Section 3 Declaration

In exercise of the powers conferred on the Governor-in-Cabinet by section 3 of the Roads Law (2000 Revision), acting upon the recommendation of the National Roads Authority, it is hereby declared:

1. It is the intention of the Roads Authority to undertake road works over the land described hereunder:

BOUNDARY PLAN: BP486

NATURE OF ROAD WORKS: To create Primary Arterial and Collector Roads as depicted in green on BP 486.

- 3. The line and anticipated boundaries of the road are shown edged in green on Boundary Plan Number 486, which may be inspected at the office of the Roads Authority, George Town, Grand Cayman, and at the offices of Lands & Survey, Tower Building, George Town, Grand Cayman.
