## NOTICE

### THE AIR NAVIGATION (OVERSEAS TERRITORIES) ORDER 2007 (SI 2007 NO. 3468)

#### OVERSEAS TERRITORIES AVIATION REQUIREMENTS (“OTARs”) 2013

Article 152 of the Air Navigation (Overseas Territories) Order 2007, SI 2007 NO. 3468 specifies that where a provision of that Order provides for the Governor to grant a certificate, licence or other document if he is satisfied as to matters specified in the provision, he shall before determining whether to effect that grant -

- (a) publish the requirements which he considers relevant to determining his satisfaction in respect of those matters in the publication issued in the Territory concerned known as “OTARs (Overseas Territories Aviation Requirements)”;
- (b) take into account those requirements.

Pursuant to the said article 152, the Governor hereby gives notice that the following OTARs, constitute the requirements which he considers relevant to determining his satisfaction in respect of an applicant for such a certificate, licence or other document -
