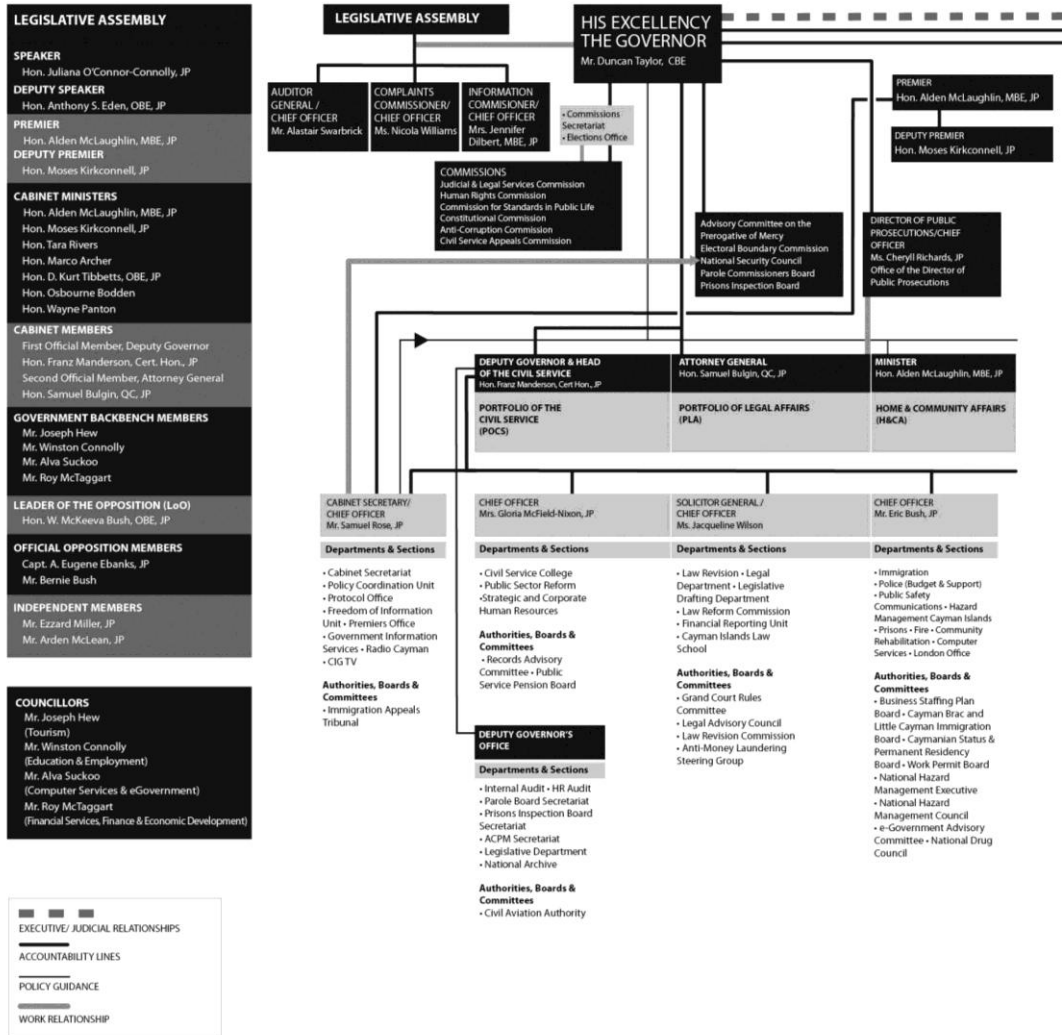

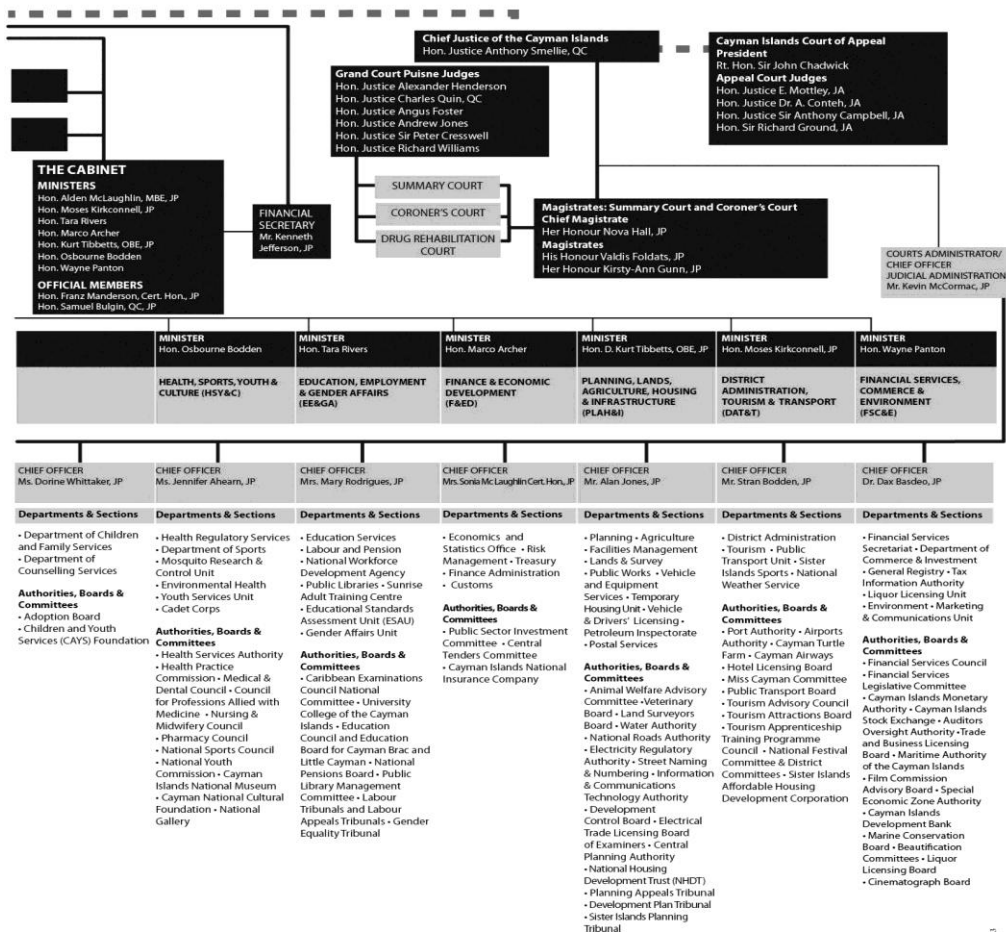
CAYMAN ISLANDS GOVERNMENT ORGANISATIONAL STRUCTURE
