Admission of children public cinematographic exhibition: Provided that admission is not prohibited if the child is accompanied by and in the charge of a person who is over the age of seventeen years. Further restriction on 9. No person under the age of seventeen years shall be admitted to a public admission of children cinematographic exhibition when the film to be exhibited has been designated as unsuitable by the British or American Film Censorship Authorities for viewing by children aged seventeen years and under. Sanitary facilities 10. All persons conducting cinematographic exhibitions shall provide such suitable sanitary facilities for persons attending such exhibitions as may be required by a health officer acting on behalf of the Board. Power to inspect fire 11. The Commissioner of Police or a health officer, from time to time, shall visit precautions and sanitary any premises where public cinematographic exhibitions are licensed to be held facilities and shall inspect all precautions against fire and all facilities for sanitation and shall report them to the Board. If the Board is of the opinion that such precautions against fire or such sanitary facilities are not adequate the Board shall call upon the licensee to remedy such defects within four weeks and if, at the end of such period, no steps have been taken to remedy such deficiencies the Board may, unless satisfied that such delay has not arisen through the wilful act or default of the licensee, revoke his licence to conduct cinematographic exhibitions for such time as the Board may deem fit. 12. The Board shall meet quarterly on the first Tuesday of each quarter, or at Meetings such other times or frequency as the Chairman of the Board may direct. The quorum of any such meeting shall be three members. Quorum 13. Balconies 14. Every cinema containing a balcony shall be provided with good and substantial stairs leading up to such balcony, and hand rails to these stairs shall be provided for the security of persons using the stairs. Stairs shall be sufficiently wide to permit persons ascending and descending to pass without difficulty. Aisles and exits 15. A central aisle shall be provided in the auditorium and an aisle on each side and the same requirements shall obtain if there is a balcony. The width of such aisle shall be not less than four feet. Not less than two exits shall be provided for an auditorium and not less than one for a balcony. The exits provided in a auditorium shall be sited as follows: One at the screen end and the other at the projection end of the auditorium. Fire precautions 16. Except where a cinema is constructed of concrete, not less than two fire extinguishers in good and efficient working condition shall be kept on each floor

of the auditorium. Where a cinema is constructed of concrete it shall be sufficient to keep one fire extinguisher in good and efficient working condition beside the projector. The cinema staff shall be trained in the use of fire extinguishers. Beside every fire extinguisher shall be placed four buckets, two containing sand and two containing water. Notwithstanding the above precautions, cinema owners shall fulfil such other requirements as may be prescribed by the Firemaster of the Islands acting on behalf of the Board.

17. A licence which is in force on the 25th July, 2002 shall-

Existing licences

- (a) continue in force on the same terms and conditions that applied on that date; and
- (b) be deemed to be subject to an additional condition that cinematographic exhibitions may be conducted on Sundays between the hours of 2:00 p.m. and midnight if the film to be exhibited has been designated by the British or American Film Censorship Authorities as suitable for viewing by children aged seventeen years and under.
