GOVERNOR (VESTING OF LANDS) LAW, (2005 REVISION)**

**PROPERTY KNOWN AS THE WESTIN, 1149 WEST BAY ROAD,  
SEVEN MILE BEACH, GRAND CAYMAN (BLOCK 11D, PARCEL 45/3)**

Whereas:

The Tenant operator of the Westin Hotel has applied for a lease extension (from 34 years unexpired to 99 years unexpired) of Crown land Block 11D Parcel 45/3.

The leased area comprises approximately 7.83 acres.

After careful analysis and consideration Cabinet has advised Her Excellency The Governor that it is in the best interest of the Cayman Islands to extend the lease to CF GC Hotel Holdings Ltd up to a term of 99 (ninety nine) years unexpired in return for a premium of US\$ 13.4 million (thirteen million four hundred thousand United States dollars) plus Stamp Duty and other Government costs.



IT IS FURTHER RESOLVED that full details of the property and of the disposition proposed shall forthwith be published in the Cayman Islands Gazette and a local newspaper and that copies of this entire resolution and of the said advertisements in the Gazette and in the newspaper, together with all other items required for the purpose of the said Section 10, shall be laid on the table of the Legislative Assembly by the Minister responsible for land.
