### ERRATA

#### The Endangered Species (Trade and Transport) Law, 2004 (Commencement) Order, 2015

*The Endangered Species (Trade and Transport) Law, 2004 (Commencement) Order, 2015 was published as Supplement No. 1 with Gazette No. 24 dated 23<sup>rd</sup> November, 2015.* 

The publication contains an error in the form of an omission of the reference to "(No. 2)" in the Citation of the Order.

This reference would correctly represent that there was a previous Endangered Species (Trade and Transport) Law, 2004 (Commencement) Order, 2015 published as Supplement No. 1 with Extraordinary Gazette No. 49 dated  $1^{st}$  July, 2015 which brought all parts of the Law, save and except for Part IV, into force.

The error is to be corrected by amending the Citation to reflect "The Endangered Species (Trade and Transport) Law, 2004 (Commencement) (No. 2) Order, 2015."
