The Cabinet, in exercise of the powers conferred by sections 18, 22 and 40 of the Trade and Business Licensing Law, 2014 (Law 21 of 2014) makes the following Regulations-

1. (1) These Regulations may be cited as the Trade and Business Licensing (Forms) Regulations, 2015.

Citation and commencement

- (2) These Regulations shall come into force immediately after the coming into force of the Trade and Business Licensing Law, 2014.
- 2. An application under section 18 of the Law shall be in the appropriate form set out in Schedule 1.

3. The certificate under section 22 of the Law shall be in the form set out in Schedule 2.
