## THE LIMITED LIABILITY COMPANIES (FEES) REGULATIONS, 2016

In exercise of the powers conferred by section 69 of the Limited Liability Companies Law, 2016 (Law 2 of 2016), the Cabinet makes the following Regulations -

1. These Regulations may be cited as the Limited Liability Companies (Fees) Citation Regulations, 2016.
