REGULATIONS, 2016**

In exercise of the powers conferred by sections 22, 23 and 75 of the Customs Law (2012 Revision), the Cabinet makes the following Regulations -

1. These Regulations may be cited as the Customs (Bonded Warehouses) (Amendment) Regulations, 2016. Citation
2. The Customs (Bonded Warehouses) Regulations (2015 Revision), referred to in these Regulations as “the principal Regulations”, are amended in Schedule 6 by repealing Part 3 and substituting the following Part - Amendment of Schedule 6 of the Customs (Bonded Warehouses) Regulations (2015 Revision)

4. The principal Regulations are amended by inserting after Schedule 35, the following Schedule - Insertion of Schedule 36

**“SCHEDULE 36**

**Part 1**

That part of the building, located at Block OPY, Parcel 92, One Butterfield Place 30 Edward Street, Unit A, George Town, Grand Cayman, consisting of an area of 50 square feet (5 feet by 10 feet), in a duty free retail shop, more particularly delineated on the plan attached to the application for approval of a bonded

warehouse (in a duty free retail shop), made by Trevor Wiseman of Cayman Cigar Emporium Ltd., trading as Old Havana Cigars, on 14<sup>th</sup> May, 2015.

**Part 2**

1. That a bond in the sum of \$5,000 with a recognised bank or insurance company be taken out to cover the duty risk in respect of the cigars in the bonded warehouse area of the duty free retail shop at any time.
2. That no goods, other than cigars which are the property of Cayman Cigar Emporium Ltd., trading as Old Havana Cigars, shall be stored in the bonded warehouse area of the duty free retail shop.
