## A LAW TO AMEND THE COMPANIES MANAGEMENT LAW (2003 REVISION) AS A CONSEQUENCE OF AMENDMENTS MADE BY THE COMPANIES (AMENDMENT) LAW, 2017 AND THE LIMITED LIABILITY COMPANIES (AMENDMENT) LAW, 2017

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as The Companies Management (Amendment) Law, 2017 and shall come into force immediately after the coming into force of The Companies (Amendment) Law, 2017.

Short title and commencement

- 2. The Companies Management Law (2003 Revision) is amended -
