### A LAW TO AMEND THE DEVELOPMENT BANK LAW (2004 REVISION), TO ADDRESS OPERATIONAL CONCERNS; TO REPLACE THE WORDS "GOVERNOR IN CABINET" WITH THE WORD "CABINET" THROUGHOUT THE LAW; TO APPOINT NEW MEMBERS TO THE BOARD OF DIRECTORS OF THE BANK; AND FOR INCIDENTAL AND CONNECTED PURPOSES

ENACTED by the Legislature of the Cayman Islands.

1. (1) This Law may be cited as the Development Bank (Amendment) Law, Sho con 2017.

(2) This Law shall come into force on such date as may be appointed by Order made by the Cabinet and different dates may be appointed for different provisions of this Law and in relation to different matters.

2. The Development Bank Law (2004 Revision), in this Law referred to as the "principal Law", is amended in sections 4, 9, 10, 12, 13, 14, 16, 17, 18, 19, 24 and 31 and paragraphs 1, 2, 4 and 12 of the First Schedule by deleting the words "Governor in Cabinet" wherever these words appear in these sections and paragraphs and substituting the word "Cabinet".

3. The principal Law is amended in section 4 by repealing subsection (2) and substituting the following subsection -

"(2) The Board shall consist of -

- (a) seven directors appointed by the Cabinet in accordance with the First Schedule; and
- (b) the following *ex officio* members who shall be non-voting members of the Board -
  - (ii) the Chief Officer in the Ministry charged with responsibility for the Bank or that Chief Officer's designate; and
  - (ii) the Financial Secretary or the Financial Secretary's designate.".

The principal Law is amended in section 12 as follows -

- (a) in subsection (2) by deleting the word "Bank" and substituting the words "Board of Directors"; and
- (b) in subsection (3) -
  - (i) by deleting the words "Governor in Cabinet" and substituting the word "Cabinet"; and
  - (ii) by deleting the word "Bank" wherever the word appears and substituting the words "Board of Directors".

5. The principal Law is amended in section 13 by inserting after subsection (3) the following subsection -

"(3A) The following persons are prohibited from acting as a personal guarantor in support of a loan from the Bank -

- (a) a Member of the Legislative Assembly;
- (b) a Member of the Board of Directors; or
- (c) a senior employee of the Bank.".

The principal Law is amended in section 21(6) as follows -

- (a) by deleting the words "1<sup>st</sup> July" and substituting the words "1<sup>st</sup> January"; and
- (b) by deleting the words "30<sup>th</sup> June" and substituting the words "31<sup>st</sup> December".
- 7. The principal Law is amended in the First Schedule as follows -
  - (a) in paragraph 1 as follows -
    - (i) by deleting the words "satisfy himself" and substituting the words "be satisfied";
    - (ii) by deleting the words "his functions" and substituting the words "that person's functions";
    - (iii) by deleting the word "he" wherever the word appears and substituting the words "the Cabinet"; and

- (iv) by deleting the word "him" and substituting the words "to the Cabinet";
- (b) in paragraph 2 as follows -
  - (i) in paragraph (1)(a) by deleting the words "his opinion" wherever these words appears and substituting the words "the opinion of the Cabinet"; and
  - (ii) by repealing paragraph (1)(b) and substituting the following paragraph -
    - "(b) five directors of the Board who, in the opinion of the Cabinet, are persons qualified for appointment as having had experience and shown capacity respectively in -
      - (i) accounting;
      - (ii) banking;
      - (iii) finance;
      - (iv) economics; and
      - (v) industry.".
