### **ERRATA**

#### ***The Public Lands Law, 2017, Law 35 of 2017***

*The Public Lands Law, 2017, Law 35 of 2017 was published as Supplement No. 7 with Extraordinary Gazette No. 39 dated 10 May, 2017.*

*Section 2 of the Public Lands Law, 2017, Law 35 of 2017 contains clerical errors which are to be corrected as follows -*

- (a) amend the definition of “Commission” as it is not in the correct alphabetical order within section 2; it should follow the definition of “commercial activity” rather than precede it;*
- (b) amend the definition of “public land” by deleting the words “or Cayman waters”; and*
- (c) amend the definition of “vendor’s permit” by inserting after the words “commercial activity” the words “, that is otherwise lawful,”.*
