The form of proxy must be lodged with the Company at the address stated above by no later than 10:00 a.m. on 2 September 2019 (Hong Kong time) being two (2) business days being any day (other than a Saturday, Sunday, public holidays and days on which a tropical cyclone warning signal no.8 or above or a black rainstorm warning signal is hoisted in Hong Kong at any time between 9:00 a.m. and 5:00 p.m.) on which banks in Hong Kong are generally open for business throughout their normal business hours prior to the date of the Scheme Meeting. Completion and return of the form of proxy will not preclude a Creditor from attending and voting in person at the Scheme Meeting, but in such event the form of proxy will be deemed to have been revoked.

Any Creditor who wishes to attend the Scheme Meeting in person should produce at the Scheme Meeting a duplicate copy of any form of proxy that was executed and delivered on their behalf, evidence of personal identity and, in the case of a Creditor which is a corporation, an appropriately certified copy of the resolution of the board of directors or other governing body of the corporation evidencing that he is authorised to act as its representative for such purpose.

Each proxy of a Creditor attending the Scheme Meeting must bring to the Scheme Meeting a copy of the form of proxy authorising him or her to act as proxy on behalf of the Creditor and evidence of personal identity. If the appropriate personal identification and authorisation evidence is not produced, that person may not be permitted to attend or vote.

By the Orders, the Courts have appointed Mr. Shiu Chi Tak (Titus), or failing him, Ms. Hung Wai Man, or failing her, any director of the Company holding office on the date of the Scheme Meeting, each a director of the Company, to act as chairperson of the Scheme Meeting and have directed the chairperson to report the results thereof to the Courts.

The Schemes of Arrangement will be subject to the subsequent approval of the Courts.
