ROADS LAW (2005 REVISION) SECTION 6 AUTHORISATION TO ENTER LANDS

In exercise of the powers conferred on the Governor in Cabinet by Section 6 of the Roads Law (2005 Revision), and acting upon recommendation by the National Roads Authority, it is hereby declared that it is the public interest to widen the road along the highway as described hereunder:

REGISTRATION SECTION: West Bay North West
REGISTRATION BLOCK: 4B
BOUNDARY PLAN: BP 626
NATURE OF ROAD WORKS: The proposed roadwork is defined by boundaries outlined in green on BP 626 and listed in the Schedule below.

1. The National Roads Authority and its agents are authorised to enter upon lands listed in the Schedule below for the purposes of road works as publicly declared as intended under Section 3 The Roads Law (2005 Revision);
2. Such authority will take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette;
3. The line and anticipated boundaries of the road works are shown edged green on Boundary Plan 626
