## **OBJECTS AND REASONS**

This Bill seeks to amend the Exempted Limited Partnership Law (2018 Revision) to permit the de-registration of an exempted limited partnership that is registered under the Private Funds Law, 2020.

Clause 1 provides the short title of the legislation.

Clause 2 amends section 43(2)(m) of the Exempted Limited Partnership Law (2018 Revision) to include in the list of exempted limited partnerships that may be de-registered under that Law an exempted limited partnership that is registered under the Private Funds Law, 2020.

  - (a) by inserting after the word "licensed" the words "or registered"; and



(b) by inserting after the words "*Mutual Funds Law (2015 Revision)*" the words ",the *Private Funds Law, 2020*".
