### GOVERNOR (VESTING OF LANDS) LAW, (2005 REVISION) PROPOSED DISPOSITION OF CROWN LAND SOUTH SOUND, BLOCK 15B PARCEL 68

Whereas:

- 1) The Cayman Islands Government proposes to transfer Crown land, Block 15B Parcel 68, located on Olympic Way, South Sound, to the University College of the Cayman Islands for education purposes.
- 2) The Parcel area comprises approximately 1.20 acres.
