In exercise of the powers conferred under Section 3(1) of the Roads (Naming and Numbering) Act (2019 Revision), the Minister for the time being responsible for Lands makes the following order –

The name “Seafarers Way” is assigned to “Harbour Drive”, the portion of “North Church Street” from “Fort Street” to “Mary Street”, and the portion of “South Church Street” from “Shedden Road” to “Boilers Road” (I.e. the road indicated by the dashed blue lines on the below map extract).
