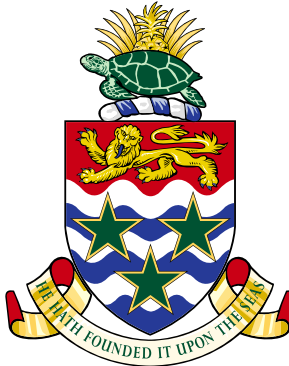

In exercise of the powers conferred by section 5(3) of the Passport Act (2004 Revision), the Cabinet makes the following Order —

**Citation**

1. This Order may be cited as the Passport (Amendment of Schedule) Order, 2021.

**Repeal and substitution of the Schedule of the Passport Act (2004 Revision)  
- fees**

2. The *Passport Act (2004 Revision)* is amended by repealing the Schedule and substituting the following Schedule —

Express service fee in respect of the certificate of identity and the document of travel to Jamaica (This fee is charged in addition to the fee set out in relation to each of those services where the service is to be completed within one business day of application)	\$75.00
