

In exercise of the powers conferred by section 34 of the Public Health Act (2021 Revision), the Cabinet makes the following Regulations —

**Citation**

1. These Regulations may be cited as the Control of Covid-19 (No.3) (Amendment) Regulations, 2021.

**Amendment of regulation 2 of the Control of Covid-19 (No.3) Regulations, 2021 - definitions**

2. The *Control of Covid-19 (No.3) Regulations, 2021*, in these Regulations referred to as the “principal Regulations”, are amended in regulation 2 by inserting after paragraph (1) the following paragraphs —
  - “(2) For the purposes of regulation 3(1)(b), a person has close ties to the Islands if the person —
    - (a) owns property or a business in the Islands; or
    - (b) is the spouse, civil partner, parent, step-parent, grandparent, brother, sister, child, step-child or grandchild of a Caymanian or resident of the Islands.

- (3) For the purposes of paragraph (2)(b) —
- (a) a parent, grandparent, brother or sister of a Caymanian or resident of the Islands means a parent, grandparent, brother or sister, including a half-brother or half-sister, of the Caymanian or resident;
  - (b) a child of a Caymanian or resident of the Islands means the biological child or the adopted child of the Caymanian or resident, regardless of the age of the individual who is the biological child or the adopted child;
  - (c) a step-child of a Caymanian or resident of the Islands means a child of one of the parties to a marriage or a civil partnership where one of the parties to the marriage or the civil partnership was a Caymanian or a resident of the Islands, regardless of the age of the individual who is the step-child; and
  - (d) a grandchild of a Caymanian or resident of the Islands includes an individual who is the adult grandchild of the Caymanian or resident.”.

### **Amendment of regulation 3 - restrictions on arrival of unvaccinated persons to the Islands**

3. The principal Regulations are amended in regulation 3(1) by repealing subparagraph (b) and substituting the following subparagraph —

“(b) an unvaccinated person who has close ties to the Islands.”.

### **Amendment of regulation 4 - restrictions on arrival of vaccinated persons to the Islands**

4. The principal Regulations are amended in regulation 4 as follows —

- (a) in paragraph (1), by repealing subparagraph (b) and substituting the following subparagraph —

“(b) a person who is —

- (i) a child of a Caymanian or resident of the Islands; or
- (ii) a child under the guardianship or care of a Caymanian or resident of the Islands; or”;

- (b) by repealing paragraph (4) and substituting the following paragraphs —

“(4) Subject to paragraphs (6) and (7), where a person referred to under paragraph (1)(a) or (b) arrives in the Islands, the person shall —

- (a) remain in isolation for a period of not less than seven days at a private residence or such other place or facility of quarantine or isolation as specified by the Medical Officer of Health; and



- (b) be subject to such directions as are provided by the Medical Officer of Health until the person receives a negative result in relation to the polymerase chain reaction (PCR) test administered to the person prior to leaving any place or facility of quarantine or isolation.
- (4A) Subject to paragraphs (6) and (7), where a person referred to under paragraph (1)(c) arrives in the Islands, the person shall —
  - (a) remain in isolation for a period of not less than —
    - (i) seven days, where the vaccination certificate —
      - (A) is issued by the Cayman Islands Health Services Authority; or
      - (B) can be securely verified; and
    - (ii) ten days, where the vaccination certificate cannot be securely verified,  
at a private residence or such other place or facility of quarantine or isolation as specified by the Medical Officer of Health; and
  - (b) be subject to such directions as are provided by the Medical Officer of Health until the person receives a negative result in relation to the polymerase chain reaction (PCR) test administered to the person prior to leaving any place or facility of quarantine or isolation.”.
